#### **Region 1 Report**

# 2024 Spring Executive Board Meeting, April 23-24 Lexington, KY

Once again, Region 1 was spared much of old man winter! The northern parts of the region had some snow, but basically spring came in by mid-February.

We held our spring Zoom meeting on March 6<sup>th</sup> with 36 participants from all over the region. With only one bid for the 2025 regional championships and one bid for the Colonel Bengt Ljunquist Memorial (CBLM) Championships, there was more time for other discussions. The meeting went for over two hours.

#### 2024 spring meeting synopsis:

The 2024 Great American Insurance Group/USDF Region 1 Dressage Championships will be hosted by the Virginia Dressage Association (VADA) at the Virginia Horse Center. The organizing committee is hopeful that that the show will retract to its usual size (which is not small) as Regions 2 and 3 have moved to more rider favorite facilities.

The 2024 CBLM Championships will be hosted by North Carolina Dressage and Combined Training Association (NCDCTA) at the Carolina Horse Park, with a change in management to Kevin Bradbury and his HorseShowOffice.com crew. Last year, the region voted that these championships may be moved down to a Level 3 dressage competition, mainly to reduce the show expenses of a Level 4. But, it still has to be run as a championship competition with mounted awards presentation and other frills. <a href="www.CBLM.org">www.CBLM.org</a> is live and up to date.

#### 2025 championships:

There was one bid from VADA, October 8-12, for the Region 1 championships. Janine Malone led the discussion and vote by the current PM delegates.

There was one bid from Eastern States Dressage and Combined Training Association (ESDCTA), August 29-31 at the New Jersey Horse Park for the CBLM Championships. These championships have made the move to earlier in the fall season, which should be a plus for everyone, as they will now be away from Dressage at Devon, regional championships, and the US Dressage Finals.

The 2024 US Dressage Finals were discussed. It was stressed that all riders need to confirm the USDF Region they are declared for, as regional championship is the only way to the US Dressage Finals.

The 2024 Region 1 Youth DressageTeam Challenge will be held at Rose Mount Farm in Spotsylvania, VA. With the change in venue, the organizing committee has been able to decrease some of the show fees to the riders. They now have a 501c3, Youth Dressage FUNdation and hope this will encourage even more sponsors. Another exciting announcement

is that this show is teaming up with Dressage4Kids for two new awards, the East Coast Youth Dressage Champion and Trainer awards. The three shows (riders must compete in only two) are: Region 1 Youth Dressage Team Challenge, Youth Dressage Festival in Saugerties, NY, and Atlanta Youth Festival.

Potomac Valley Dressage Association (PVDA) is once again hosting the Adult Amateur Team Challenge at their November show, held at the Prince Georges Equestrian Center. They have some cool plans in the works for this year's competition.

The 2024 North American Youth Championships (NAYC) will be held July 30-August 2 in Traverse City, MI. Currently, our region does not have the usual number of either junior or young rider applicants, but Debbie DelGiorno is confident they will apply (hopefully before the fees increase).

The 2024 youth clinic with George Williams is confirmed for November 23 - 24. We are still waiting for the facility to confirm.

Debbie also discussed the youth outreach clinics with Olvia Lagoy-Wentz. Olivia has generously donated her time, so the only cost to the riders will be her expenses and the facility costs. These clinics are aimed at the up and coming juniors/young riders who need exposure to the FEI experience. It is planned to host these clinics in all parts of the region.

Our region is very fortunate to have at least four CDIs scheduled for 2024. The Mid-Atlantic Dressage Festival, May 16-19, will kick off the 2024 Region 1 CDI season once again with a full CDI3\*, and more competitions at the Virginia Horse Center in Lexington, VA. The Boutique CDI 3\* will be held June 20-23 at the Rhythm & Blues Equestrian Center in Quakertown, PA. Dressage At Devon will be held September 24-29. The master class is continuing with the announcement of the presenter later this spring, and the dance off is also happening again. Dressage sport horse breeding (DSHB) starts this competition off on Tuesday, with the USDFBC East Coast Series Championships on Thursday, along with the FEI jog, young horse tests, and a full CDI schedule throughout the rest of the week. GP freestyle will again be under the lights on Saturday night. Tryon Fall Dressage 2 is scheduled for October 24-27 at the Tryon International Equestrian Center in Tryon, NC. It is a full CDI3\*. #### GMO happenings:

- Commonwealth Dressage and Combined Training Association will offer five schooling shows and one licensed show in June, along with clinics and fix-a-test clinics.
- Delaware Valley Combined Training Association is offering a schooling show series.
- ESDCTA will host a freestyle clinic and seminar April 13-14 with Terry Ciotti Gallo. Their Memorial Day weekend show will have both performance and DSHB classes. Other licensed shows are scheduled throughout the summer and early fall. All licensed shows offer CBLM qualifying classes. They are working on a youth outreach program and their year-end awards will include some for breeders and handlers.
- Lehigh Valley Dressage Association is using 2024 as a restructuring year. The new focus
  will be on education for the equestrian athlete. They are working with the Red Cross for a
  first aid/CPR class with emphasis on the trainers in the area. They will host a series of howto with Samantha St. Jacques, including a cavetti clinic and seven schooling shows. Their

- year-end awards have been expanded to include awards for riders on school horses. To facilitate volunteer sign up, they will use Sign-up Genius.
- Maryland Dressage Association has six schooling shows in their pipeline, cumulating with a championships show. A fix-a-test is planned and they are revamping their volunteer program to hopefully find a better way to reward their current volunteers and recruit even more.
- NCDCTA will have four licensed shows, including the CBLM Championships. Jillian Klein
  will be the presenter for their yearly educational event to be held July 19-21. It will focus on
  the neck of the horse as a part of its functional anatomy. They are adding pony and small
  horse championships to their end of the year championships. They also offer a structured
  scholarship program.
- PVDA will host five licensed competitions this year, with their spring show moving to Loch Moy. They have seventeen schooling shows planned, a balanced partnership clinic, and the annual chapter challenge.
- VADA will host an L program starting in December at Old Raptor Farm in Louisa, VA. Four
  of the eight chapters host licensed competitions with most hosting clinics and/or schooling
  shows. VADA itself hosts Dressage at Lexington (July 14-16), featuring the Sporting Horse
  Amateur Challenge (SHAC), Maestro Cup Grand Prix, PSG, Int I, USDF and FEI FS
  Challenge classes, ending the year with the 2024 Adequan/USDF Region 1 Dressage
  Championships.

A new logo contest was undertaken by Debbie DelGiorno. A flyer was posted on our Region 1 website asking for possible logo submissions from our members. Debbie received thirteen! After careful review, Debbie then contacted the embroiderer used by the region for their input. All were very creative but would either not embroider well, expand to banner, or contract to business card sizes. Our region is very fortunate to have so much talent! The final choice was submitted by Paige Zimmerman. We are so excited to have a new, modern logo and I personally can't wait to use it!

All NAYC applicants take part in the fundraising activities for the next year. If the number of applicants for 2024 does not reach the usual level, there may be a drop in their fundraising amounts and Debbie hopes the region's members will continue to be as supportive as they have been in the past.

Lori Kaminski and I are working hard to fill the region's Participating Member delegate slots, but regrettably Houston seems to be a hard sell.

I'm now one third of the way through my third term as Region 1 Director. Every regional Zoom meeting amazes me with the commitment to and by our GMOs to their members. The level of volunteerism in our region is a tribute to the GMOs ability to listen and react to their members.

Going forward into 2024, I look forward to getting the new logo out for all to see and I will continue to educate the GMOs on what USDF has to offer and is currently doing for their members.

# 2024 Spring Executive Board Meeting, April 22-23 Lexington, KY

Region 2 continues to be well represented on USDF committees and within the ranks of USEF officials. Our competitors reflect the values and training they have received as they successfully compete on the regional and national levels. We had excellent representation at the 2023 convention.

All seventeen GMOs are accounted for; however, it seems that many memberships are coming in slowly or perhaps they are not being reported yet.

Regarding GMO award banquets, most GMOs did have one this year, although many are held in January or February instead of the end of the year.

#### Region 2 Communications:

- The region continues to promote dressage clinics, schooling shows, and education programs via social media outlets (website and Facebook).
- PM delegates continue to be handled by Molly Fine of IDCTA. This year Region 2 can elect twelve delegates.

#### Region 2 Education Update:

- The Region 2 Education Committee is headed up by Anna Cluxton and includes Cathy Jacob and Kristine Downes.
- Education Challenge Award winners were drawn at the convention.
  - One for the most USDF credits earned in the past year
  - o One from the Catherine B. Jacob Schooling Show Awards (CBJSSA) Program participants over the past year
- A Jr/YR clinic has been scheduled for this fall with Lilo Fore
- GMOs continue to offer USDF programs as well as their own original activities

#### Region 2 Competition Update:

- There are currently 110 recognized shows on the books for 2024. For comparison, in 2023 there were 109, 2022 there were 114, in 2021 there were 100, in 2020 there were only 58 and in 2019 there were 120.
- Region 2 continues to benefit from and support the CBJSSA Program via the Region 2 website and Facebook page. This year, the CBJSSA Program contributed over \$750 to our education fund.
- National Dressage Pony Cup (NDPC) and Small Horse Championships and NDPC Partner Show will again be in July at the World Equestrian Center (WEC) in Wilmington, OH.
- The North American Youth Championships (NAYC) will be held in Traverse City, MI:
  - Region 2 chefs d'équipe for the juniors will be Shari Wolke and for the young rider team will be Laurie Moore. Roz Kinstler continues to be our youth coordinator.
  - We need a fundraising chairperson! Starting with an earlier fundraising campaign. All riders that put in declarations are required to contribute. The goal is \$13,000.

- The U.S. Dressage Festival of Champions will be held in August at HITS Lamplight in Wayne, IL
- The Great American Insurance Group/USDF Region 2 Dressage Championships will be held at the Kentucky Horse Park in September.
- The US Dressage Finals will be held November 7-10, 2024, at the Kentucky Horse Park.

#### **Region 3 Report**

# 2024 Spring Executive Board Meeting, April 23-24 Lexington, KY

The backbone of our regions is our Group Member Organizations (GMOs). They welcome and nurture the newest members in dressage, creating our grassroots seeds that allow us to advance to the highest levels. Without this base, we don't evolve.

Region 3 currently has nineteen GMOs. All five states have them. Our largest, Georgia Dressage and Combined Training Association, has 594 members. Six still need the minimum number of members for a vote at the annual meeting, but they are growing. We currently have 1,518 GMO members.

Two points have come up this spring that Region 3 needs to be thinking about: 1) We would like to establish a "mentor" system to help smaller GMOs thrive and 2) It has been suggested that an "umbrella" GMO be established in areas where there are no GMOs for riders who want to belong to one. The idea of chapters has come up. Currently, only one GMO in Region 3, Deep South Dressage and Combined Training Association, has chapters.

Show numbers are up this year. We have 160 shows listed on the USDF website calendar. Eighteen are CDI's. Florida and Georgia make up more than 50% of those listed. With the most southern climates, they have a longer show period. All of our states have listed shows. A lot of riders choose to come south to train and show in the winter. Many join our GMOs; it's hard to tell at times how many are full time residents.

USEF lists 25 "S" judges in Region 3, 5 of whom are also FEI. Also, we have 14 "R" judges, 15 "r" judges, and 60 L graduates, 28 being with distinction.

In education, the South Carolina Dressage and Combined Training Association is holding two programs for instructor development in March and May. They are being offered remotely and will allow continuing education credits for L graduates.

Elizabeth Molloy organized both the FEI Young Rider Clinic with Lilo Fore in January at Noble Steeds Farm in Canton, GA and the USDF Region 3 Youth Outreach Clinic, also at Nobel Steeds, in March. Liz will again be leading our teams to the North American Youth Championships (NAYC) as chef d'equipe. Applications are currently coming in for the NAYC young rider and junior teams. We have five listed as junior hopefuls, two of which are returning riders from the 2023 team.

The survey/wrap up of the Great American Insurance Group/USDF Region 3 Dressage Championships at the Florida Horse Park in Ocala, FL showed that the riders appreciated the hospitality and effort by the organizing team. The use of tenting for stalls again was a concern, and increasing the amount of time allowed for schooling was suggested.

In 2024, our regional championships will move, but not too far. They will be held at the World Equestrian Center (WEC) in Ocala. Since its opening, competitors have asked for this venue.

The rings used for the championships will be the indoor arenas with the adjacent stabling. Teresa Uddo will be heading up the management for 2024. Our eight person/five state committee who is reviewing applications for 2025 is currently making their recommendation to the national committee and Executive Board for their approval.

The Region 3 John Kimball Adult Amateur Championships will be held June 1-2, 2024, in Newberry, FL. A committee headed by former Region 3 Director, Sue Bender, is researching a venue in another state to move the "Kimball Championships", hoping to involve more riders from other states. This is where our adult amateurs shine in the spotlight. There is also a full card of open and junior classes. The facility, formerly Canterbury Show Place, has been purchased by Alachua County and many upgrades have been made in footing and stabling.

# 2024 Spring Executive Board Meeting, April 22-23 Lexington, KY

It continues to be my pleasure to serve as Region 4 Director. The region continues to grow through its member involvement. We are well represented on USDF committees. Although our number of USEF licensed officials is low, those who hold licenses are active! We have members throughout the region actively participating in programs directed towards becoming licensed officials. We all owe a debt to those GMOs and groups willing to offer educational opportunities to make this possible. Our competitors reflect the values and training they have received as they successfully compete on the regional, national, and international levels.

We had a fantastic time at this year's 2023 Adequan®/USDF Annual Convention! Omaha was an exciting and welcoming city with many opportunities for attendees. Due to an increase in membership in the region, we maintained our roster of four Participating Member (PM) delegates. All four were in attendance this year at the Board of Governors (BOG). For as many years as I can remember we had the highest number of designated Group Member Organization (GMO) delegates in attendance and all GMOs submitted proxies prior to the start of the BOG. We received one application to host the 2025 Great American Insurance Group/USDF Region 4 Dressage Championships. The committee will evaluate the application and will have a recommendation by the deadline. Due to the cost of putting on the regional championships, Maffitt Lake has notified me that they will no longer be submitting applications to host. It will be difficult to replace this facility. Intended primarily for TDs, these materials are available to all USDF members, and the module quizzes earn USDF University credit. (Members will find these learning modules by logging in to the USDF website and choosing 'Technical Delegates' from the Education tab at the top of the home page. After perusing the materials on this page, click the green button to dive deeper into the TD educational materials.)
- 2. I also chair the PR group for this committee. Our mission is to raise awareness of dressage competition participants -- judges, riders, trainers, management -- about what TDs do and how we can help them have a better show experience.
- 3. Region 6 member Peter Rothschild and I created and administer the Dressage Competition Management Forum on Facebook. This is a closed group where TDs, managers, and secretaries of all levels of dressage competition and experience can share with and learn from each other. I encourage all managers and secretaries of any kind of dressage competition, any level, to join the group and bring their questions, concerns, and advice.

The Competition Management Committee continues to work on providing quality educational events, both online and at the USDF convention. They are also available to all competition management to help with mentoring and answering questions throughout the year as needed.

Many thanks to our GMOs who were able run a few educational events this past year and to our private barns who also have hosted some wonderful events. We could not be the strong region we are without your efforts. I look forward to working with you again this coming year.

## 2024 Spring Executive Board Meeting, April 23-24 Lexington, KY

#### Aloha State Dressage Society (ASDS)

ASDS will again hold its four show series but it will now be two days of shows each weekend. "S" judges Melissa Creswick, Katy Barglow, and Barbi Breen-Gurley will be at Hilltop Farms and "S" judge Cindy Canace will be judging at Maunawili Farms.

It was a pleasure to see two representatives from ASDS attending the 2023 Adequan®/USDF Annual Convention to carry votes and glean information.

As usual, these GMOs continue to provide education and shows for their members to continue and grow with their horsemanship.

#### California Dressage Society (CDS)

This 2024 show season currently has 100 approved shows, which is a bit less than the normal (120 shows in a season). While a few dates have been cancelled, a few other shows are hoping to pick up those available dates; and others are considering chapters and private individuals adding dates to their calendars.

There is a trend for some CDS chapters; moving from 3\* shows to 1\* shows or moving from 1\* to a schooling show. This is mostly due to high fees, lack of facilities, or high facility costs. But, CDS members are still willing to show, and so far, there are 343 riders who have nominated themselves for the CDS championships, 70 riders for the two junior/young rider championships, and 275 riders for the three regional adult amateur championships (RAAC). Qualifying for these three types of special events can be done at a 1\* show.

CDS continues to offer scholarships for everyone: juniors, young riders, adult amateurs and professionals, judges, educational events, and some which are specific to individual chapters.

The Linda O'Carroll CDS Adult Amateur Clinics: one held in each of the three regions, and were very successful with Heidi Gaian as the 2024 clinician. The two junior/young rider clinics will be held in May with David Wightman.

In keeping up with education and information, CDS has had three "Ask the Experts" webinars with Melissa Creswick, Joan Williams, and Axel Steiner. Chapters are offering Zoom clinics that cover balanced riding, breathing, and other topics. They are open to all members and non-members alike. There are still live clinics offered with exceptional clinicians, such as Lisa Wilcox.

#### Other interesting things going on:

- US Equestrian appointed Region 7's Christine Traurig to the role of development coach and she will be the chef d' equipe for the Olympics.
- A USDF Handler Clinic at the Pacific Equestrian in Wilton, CA.
- While ten CDI's were planned, only eight will be held in the 2024 show season in the Southern California area.
